

Knolls Village Townhouse Association Swimming Pool Rules

POOL ATTENDANTS HAVE SOLE RESPONSIBILITY FOR OUR FACILITY AND ALL FACILITY RESOURCES

To use the pool, homeowners must have a signed Pool Agreement on file with the Association, as well as a current Pool Registration Card. The Pool Registration card expires and must be renewed upon expiration.

Residents whose monthly HOA fees/dues are not current will be denied use of pool facilities.

- The pool opens for the season on Memorial Day weekend and closes on Labor Day. It is open daily from 9:30 a.m. until 8:00 p.m. weather permitting.
- The pool is reserved daily for adults only between **9:30-10:30 a.m. and 5:30-6:00 p.m.**
- All other times between 9:30 a.m. and 8:00 p.m. the pool is open to all eligible KVTA pool users.
- When the weather forecast is for cool weather the pool staff determines whether to open the pool that day.
- See a pool attendant to register for using the pool.

Please do not enter the pool area when the pool is closed. It is dangerous to enter the pool area while closed because the pool is covered to preserve heat and no attendant is present. Doing so could result in loss of pool privileges for the entire family of the individual trespassers.

If you are new to the Village and need to register for a pass and a key, come to the pool and see the pool attendant.

If you are a renter, you must provide a *Tenant Release Form* signed by the homeowner to use the pool facilities. Submit the Tenant Release form at registration. The form is available to download from the KVTA website – www.knollsvillage.com or obtained from a pool attendant.

POOL REGULATIONS

Use of the pool and facilities is strictly at your own risk.

There is no lifeguard on duty.

Running, splashing, or nuisance activities are strictly prohibited.

- 1) No glass or breakable containers are permitted in pool areas.
- 2) Alcohol and tobacco products are prohibited in pool areas.
- 3) Pets (leashed or otherwise) are not permitted in pool areas.

- 4) Children who are household members between the ages of 13 to 15 will be allowed to sponsor 1 guest. Children who are household members ages 16 to 20 may sponsor 2 guests.
- 5) Children under the age of 13 must be accompanied at all times by a parent or other authorized adult.
- 6) Guests must be accompanied by a resident and the notify pool staff if they are unable to accompany guest(s) or will not remain at the pool while their guest(s) use the facility. Guests are non-residents.
- 7) Guests of residents are limited to 5 unless previously approved.
- 8) Pool privileges will be **suspended** in instances of vandalism.
- 9) Wading pool use is reserved for children age 6 or under and must be accompanied at the wading pool by a parent or authorized person, age 18 or older.
- 10) Children not yet toilet trained must wear a special swim diaper.
- 11) Shower facilities are available for both before and after pool use and showers must be kept to a 5 minute maximum.
- 12) Flotation devices may be limited and require approval from the pool attendant on duty.

We encourage everyone to help keep our pool areas safe and clean.

The Pool Gazebo area may be reserved for a two-hour period only for a maximum of 15 people. The Gazebo may not be reserved concurrently with the Clubhouse. See the pool staff on-site for Gazebo reservations.
